- Along with a photo of your entry, please include your name and age or the details of the entrant you are submitting on behalf of
- Entries are open from Monday August 2<sup>nd</sup> until Wednesday August 18<sup>th</sup> at midday.

### Arty August Terms and Conditions

Arty August begins on Monday August 2<sup>nd</sup> until Wednesday August 18<sup>th</sup> at midday. Entries which meet the guidelines above will initially be shortlisted by the team at the RSPCA Mid Norfolk and North Suffolk Branch, and then put to a public vote between Friday 20<sup>th</sup> August and Tuesday 24<sup>th</sup> August 2021. The public vote will take place on the Arty August Facebook event page and on the Branch website ([www.rspcanorwich.org.uk](http://www.rspcanorwich.org.uk)).

### Winners will be notified on Wednesday 25<sup>th</sup> August.

1. The Arty August competition is open to residents of England and Wales. Entrants under the age of 18 must get permission from a parent or guardian before entering.
2. The Arty August competition is organised by the RSPCA Mid Norfolk and North Suffolk Branch, Ashwellthorpe Hall Drive, The Street, Ashwellthorpe, Norfolk NR16 1EX (“the Promoter”).

3. Entry into the Arty August competition constitutes acceptance of these Terms and Conditions and any entry found not to comply with them will be disqualified.  
Entries will be accepted on the Arty August Facebook page, by using the #ArtyAugust hashtag on Instagram and Twitter or by emailing the Branch at [woof@rspcanorwich.org](mailto:woof@rspcanorwich.org)
4. All entries must comply with the Competition Guidelines as outlined above. Entries must be entrants own work. The only exception to this is if a parent or guardian is submitting on behalf of their child. Please do not include any images of a person or people in your photo
5. Only one entry per person, per platform, will be accepted.
6. Arty August is not open to employees or immediate family members of employees of the RSPCA Mid Norfolk and North Suffolk Branch, its subsidiaries, agents or anyone else professionally connected to the competition.
7. There will be four winners in total across four different age categories. The selection panel will shortlist their favourite submissions across each category before the winner will be decided through a public vote. There will be no runner-up prizes.
8. By entering a photo of your artwork, you give the RSPCA Mid Norfolk and North Suffolk Branch express permission to share this content on its social media channels, website and other communications, and to make minor edits to the content.
9. You agree to grant the Promoter a non-exclusive, worldwide, irrevocable licence in perpetuity of the copyright and other intellectual property rights in your photograph, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-license your photograph for such purposes.
10. Each winner will receive: a selection of RSPCA Merchandise, the displaying of their artwork as the cover photo for the RSPCA Mid Norfolk and North Suffolk Branch Facebook and Twitter pages for a week, and a certificate from the Branch. There is no cash alternative. The winner will be notified by private message on the platform that the image was originally shared on, on or after 25<sup>th</sup> August 2021 and given details of how to claim their prize. The RSPCA Mid Norfolk and North Suffolk Branch will arrange and cover the cost of postage of prizes to the winners to their chosen address in England & Wales within 10 days of the closing date. The Promoter does not accept any responsibility if you are not able to take up the prize. If any entrant selected to win a prize does not respond to claim their prize by 30<sup>th</sup> August 2021 the Promoter may select another eligible entry to receive the prize in substitution or, if there is insufficient time for delivery of the prize by the means of postage chosen by the Promoter, the Promoter may withhold the prize. The winner's names will be published soon after they have been notified on all RSPCA Mid Norfolk and North Suffolk Branch social media channels including Facebook, Twitter and Instagram and the Branch website.
11. The prize is subject to availability. Events may occur that render the competition itself or awarding the prize impossible due to reasons beyond the control of the Promoter who may at their absolute discretion vary or amend the competition and the entrant agrees that no liability will attach to the Promoter as a result.
12. The Promoter reserves the right at any time to modify these terms and conditions, alter or discontinue the Arty August competition if deemed necessary in their opinion or if circumstances arise outside their control.
13. The decision of the Promoter in all matters relating to the Arty August competition is final and binding and no correspondence will be entered into.
14. The Promoter will not accept responsibility for entries that are lost, mislaid, damaged or delayed, regardless of cause, including, for example, as a result of any equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
15. The Promoter reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.
16. The Arty August competition and these terms and conditions will be governed by English Law and is subject to the exclusive jurisdiction of the English Courts. Privacy Statement.
